REQUEST FOR PROPOSAL AMENDMENT NOTICE

Introduction

On October 10, 2024, the publication of the Request for Proposal ("RFP") marked the beginning of the RFP stage of the competitive selection process in accordance with Armenian law and international best practices (the "Selection Procedure"). As a result of the Selection Procedure, the Government of Armenia (hereinafter – "GoA"), represented by the Ministry of Internal Affairs (hereinafter – "MIA") aims to enter a public–private partnership ("PPP") agreement for the issuance and distribution of identity documents and operation and servicing of the ID facilities in the Republic of Armenia ("PPP Project"). With this letter the GoA is announcing the amendment of the Request for Proposal, which corrects some technical errors and provides clarification on certain procedural matters.

Amendments to the Request for Proposal

Upon careful evaluation of the feedback provided by the Qualified Applicants since the publication of the RFP, the Evaluation Commission has approved a limited number of non-material changes (correction of technical errors and further clarifications to the interpretations of procedural matters) to the Request for Proposal in the following sections of the RFP document package:

Please note that all of the changes detailed below are further clarifications to the RFP, that do not affect the nature, scope, and requirements of the RFP, hence the adjustments are classified as **non-material changes** to the RFP and the <u>Bids Submission Deadline will not be postponed</u>.

The Qualified Applicants shall submit their Bids no later than **18:00 (Yerevan Time)** on **Wednesday, January 8, 2025**.
