Introduction

On October 10, 2024, the publication of the Request for Proposal ("RFP") marked the beginning of the RFP stage of the competitive selection process in accordance with Armenian law and international best practices (the "Selection Procedure"). As a result of the Selection Procedure, the Government of Armenia (hereinafter – "GoA"), represented by the Ministry of Internal Affairs (hereinafter – "MIA") aims to enter a public–private partnership ("PPP") agreement for the issuance and distribution of identity documents and operation and servicing of the ID facilities in the Republic of Armenia ("PPP Project"). With this letter the GoA is announcing the amendment of the Request for Proposal and a postponement of the Bids Submission Deadline.

Amendments to the Request for Proposal

Upon further evaluation of the feedback and clarification requests submitted by the Qualified Applicants since the publication of the RFP, the Evaluation Commission has taken decision to amend the Technical Requirements as well as to postpone the Bids Submission Deadline by 30 days to allow the Qualified Applicant more time to prepare and submit their Bids.

The Qualified Applicants shall submit their Bids no later than 18:00 (Yerevan Time) on <u>Friday</u>, <u>February 7</u>, 2025.
